Divisions:

Open Division: Any Rider on a Four, Five or Six Year Old Registered Appaloosa
 Non-Pro Division: Rider must meet the Non-Pro Conditions, on a Four, Five or Six Year Old Registered Appaloosa
 Non-Pro May Enter Both Divisions. Youth may enter the Non-Pro division provided they meet the Non-Pro conditions.

Entry Fee;

Due: Postmarked on or before April 10, 2010
 Open:- \$100 Non-Pro : \$50 Both: \$125
Late Entries: Postmarked after April 10, 2010 but before April 25, 2010
 Open: \$200 Non-Pro \$100 Both: \$300
Post Entries: Postmarked after April 25, 2010 and accepted up until noon the day of the Derby
 Open: \$350 Non-Pro: \$250 Both: \$600

Judges Fee: There will be a \$20 Judges Fee for each entry.

Conditions:

- This event is run in compliance with NRHA rules unless otherwise stated in this entry form. The decision of the judges officiating the event and/or the governing ARHA Board of Directors is final.
- Stall reservations must be made with the ApHC National Show.
- Both Divisions will run **concurrently**. The Derby will be one go only, held on Saturday, May 1, 2010. Payback and placing will be per the NRHA payscale. 30% of the entry fees will be retained.
- Non-Pro must hold a current ApHC Non-Pro card and must meet the Non-Pro conditions. Youth are eligible for the Non-Pro division provided they meet the Non-Pro conditions. Youth must sign a Non-Pro declaration, Non-Pro's must show their valid ApHC Non-Pro Card.
- Both the owner and rider must be a current member in good standing of both the ApHC and ApRHA.
- A copy of the horses papers must accompany this entry form.
- Horses subject to inspection by the ApHC Staff – entry numbers must be stamped.
- Current negative coggins test and health papers will be required
- NRHA Patterns will be used
- Both Divisions are one-handed events
- There will be no refunds given for any reason.
